# Congratulations! We are delighted to inform you that you have been shortlisted for Stage 2 of the John Moores Painting Prize 2016.

This Stage 2 entry pack includes guidelines on how to send and pack your work, full details of the collection depots, and the dates and times of when to deliver your work. It also includes labels, two adhesive and one tie-on, that you will need to send in your work.

#### **CATALOGUE** - Please read carefully

You are asked to supply a personal statement of **no more than 200 words** and an accurate and up to date CV about yourself.

Your personal statement and CV should be word processed or typed where possible. If you are selected for the exhibition display, both documents will be edited and used in the exhibition interpretation, printed and online catalogues, website and for press and publicity purposes.

Please do not attempt to write your own biography - please supply information in the format stated below.

**PERSONAL STATEMENT** - Please see attached entry form.

**CV** - Please supply information in CV form. This should be no more than one side of A4. Please include:

- Where you studied (we have space for three or four courses). Include location and date; format as in this example:
  - Canterbury College of Art & Design, 1989-92.
- Eight key exhibitions and/or other projects (eg. residencies). Include title, date, venue, place, and whether group or solo projects; format as in this example:

Jerwood Drawing Prize, 2005, Jerwood Space, London (group).

#### STAGE 2 ENTRY FORM SUBMISSIONS

The completed Stage 2 entry form must be submitted online or received via the post no later than 12 noon MONDAY 22 FEBRUARY 2016. If the form is not received by this date your entry will be invalid.

#### **EXHIBITION DATES**

The exhibition will open to the public on **9 JULY 2016** at the Walker Art Gallery, Liverpool, and run until **27 NOVEMBER 2016**.

#### JURY NOTIFICATION

You will be informed of the jury's decision as soon as possible after the conclusion of the judging in April. If you have not heard by **TUESDAY 12 APRIL 2016**, please contact the John Moores office. Please do not contact us for a decision before this date. We are unable to respond.

Unsuccessful works will be returned to depots for artists to collect from **16-19 APRIL 2016**. Exact dates will be confirmed in your notification following Stage 2 judging.

The jury's word is final and no discussion can be entered into.

#### TRANSPORT ARRANGEMENTS

The depots will only receive entries during the days and times given. If these arrangements are unsuitable, please contact your chosen depot directly using the details provided to discuss arrangements and to ensure that someone is there to receive your work.

Work entered through the Belfast, Bristol, Leeds, London or Scotland depots will be transported by the organisers to Liverpool for final judging.

You must take your work to the chosen depot specified on your Stage 2 entry form.

Please ensure that your work is adequately wrapped and protected (see packing guidelines). A work that is inadequately wrapped, in the opinion of the depot staff, will be subject to a re-wrapping charge to the entrant. Please notify the John Moores exhibition office in advance if your work has an exceptionally fragile surface or if you think the action of unwrapping the work could endanger it.

Please ensure that the official label is visible on your wrapping. Depot staff are instructed not to accept works where no official label is visible. We regret that depot staff are not able to answer enquiries concerning the exhibition.

#### RETURN OF WORKS

Unsuccessful entrants will be notified by letter of the dates and times for the collection of their work. Please note that this letter will also include a receipt for the work's return. This receipt must be presented at the depot when the work is collected. Works not selected will be returned to the depot through which they were submitted, unless the entrant clearly indicates otherwise on the Stage 2 entry form.

Artists unable to collect their work during the period specified should contact the appropriate depot to make alternative arrangements. Late collections will incur storage charges for the artists of up to £10 + VAT per day. This must be paid directly to the depot by the artist on collection. Every effort will be made to contact artists regarding unclaimed works, however works unclaimed after 6 weeks will be destroyed.

Works will be returned in crates or boxes where the artist has supplied these but it is regretted that other packaging cannot be returned. Un-crated entries will be re-wrapped by the organisers for their return.

Exhibitors' work will be returned to the depots after the exhibition has closed on **SUNDAY 27 NOVEMBER 2016**. Details about these returns will be sent to artists prior to the close of the exhibition.

If the work is sold during the exhibition, the Walker Art Gallery will make arrangements directly with the purchaser who will be responsible for the collection.

#### **PACKING GUIDELINES**

Entrants can submit their works wrapped or, if preferred, in a crate or transit crate (measuring no more than 3m x 3.75m). The following are general guidelines for the wrapping and protection of works during transport. They are intended to help protect both your own and other artists' work. Please follow them wherever possible.

#### A. WET OR TACKY PAINT

Please do not submit work that is still wet or tacky. Such works are extremely vulnerable in transit and, once unwrapped, become a hazard to other works of art. We reserve the right not to unwrap works that are discovered to be wet or tacky. Such works may be declared invalid.

#### **B. LABELLING**

Please fill in all the details on the set of labels provided. The tie-on label should be attached securely to the reverse of the work at the top. The appropriate self-adhesive label should be stuck to the back of the work, if possible on the frame or stretcher.

If the work is on canvas, **do not stick the label to the back of the canvas**. Your second self-adhesive
label should be attached securely to the outside of
the crate or wrapping so that it is clearly visible.

#### C. WRAPPING

#### Unframed work

- 1. First, completely wrap your painting in strong, clean, clear polythene. **Bubble-wrap should not be used for this wrapping.**
- 2. Then seal the edges of the wrapping on the reverse side with parcel tape, near the edge of the work. Make sure all the edges are completely sealed.
- 3. On the outside of the polythene, use Jiffy pads, bubble-wrap or cell-air foam to make protective corner pads (see figure 1). Attach them to the wrapping with parcel tape.

**NB:** If an unframed work has a vulnerable surface or high impasto, some form of extra edge protection should be provided before wrapping or it should be placed in a transit frame.

#### Framed work (unglazed)

Before fully wrapping in polythene and adding protective unglazed corners as described above, tie cotton tape or ribbon around the frame, with tissue or cell-air foam padding under the tape to protect the frame. The tape prevents the polythene wrapping from touching the paint surface (see figure 2).

#### Framed work (glazed)







FIGURE 3 FRAMED WORK – GLAZED

Before fully wrapping in polythene and adding protective corners as described above, place strips of low-tack glass tape in a regular criss-cross grid pattern on the glazing (see figure 3). Do not allow the sticky surface of the tape to come into contact with your frame surface. **Please do not tape perspex.**

Corners can be made from Jiffy pads, bubble wrap or cell-air foam.







#### FIGURE 2 FRAMED WORK – UNGLAZED

The method shown should only be used if the frame edge is higher than the paint surface.

Work under glass should have low-tack glass tape stuck across the glass surface as shown. This will help protect the picture if the glass breaks during transit. **PLEASE DO NOT USE MASKING TAPE OR TAPE PERSPEX**

If in your statement you have quoted at length from another publication or writer, you must give details of the author, source (book, title etc.) and the publication date. This information does not count toward your 200 word limit.
